MEMORANDUM TO: Deputy Ministers

SUBJECT: New and updated COVID-19 resources

I am writing to provide an update on new and updated occupational health and safety (OHS) COVID-19 resources and are seeking your support in promoting them to your sectors. An inventory of these resources can be found below.

 - This free, 30-minute eLearning program will equip workers in all types of workplace with information about how infections are spread and what actions workers can take to protect themselves and others from infectious hazards that may exist in their workplace
